

2014 SHOOTOUT AT THE CHAPARRAL

COMPETITION RULES & GUIDELINES OVERVIEW

*NEW & UP-DATED FOR 2014!

INSURANCE: All competing groups must submit, no later than one week prior to event date, a Certificate of Insurance, listing as "Additional Insured's": Pima County, Arizona, Old Tucson Company 201 South Kinney Road, Tucson, Arizona 85735 "and" Dr. Buck Productions, P.O. Box 7123, Goodyear, Arizona 85338, to be eligible for competition. All entry monies will be forfeited if this is not completed. Groups needing Insurance are encouraged to go to: www.thereenactors.com for Best in the West Insurance! *But please do not wait until the last minute, as it may take a couple weeks to get your insurance coverage.*

GROUP SIZE:

A maximum of Twenty (20) "Performing Members" per group will be allowed on each day.

SHOWS:

Each group must be prepared to present Two (2) shows. One for Saturday and one for Sunday. *Plus, in case of a "Tie", each group should be prepared to perform a "Tie-Breaker" show, using the show content elements given to them from the head judge. You will have 15 minutes to create your show.*

Shows can be of a Fictional or Historic nature and can be serious, comedic, or a combination of both .

All blanks & black powder loads {all calibers & shotgun}, must be approved by Dr. Buck Productions personnel. All weapons and loads will be thoroughly inspected before and immediately after each performance. All persons firing weapons must be at least 18 years of age.

Dr. Buck Productions and/or Old Tucson have the right to stop any performance they feel is inappropriate or unsafe at any time.

STUNTS, PROPS & SPECIAL EFFECTS: All stunts, props and special effects must be cleared through, and if needed, tested by Dr. Buck Productions professional stunt personnel, and if necessary, through Old Tucson, before competitions begin. Groups must have a "Plan-B" in place, in the event that a stunt, prop or special effect is deemed unsafe.

JUDGING: Complete Judging criteria will be outlined in the Group packets.

Judges will consist of a variety of Professional Performers, Actors, Casting Agents, Directors or Stage Performers. Judge's decisions are final.

GROUP ENTRY FEE: \$50 Reservation fee due no later than January 1, 2014... Balance of \$100.00 due and payable on or before February 1, 2014.
